



SUBJECT: 2017 Automatic Aid Additions

In our effort to continue to enhance our regional approach to emergency response throughout Travis County, I am pleased to welcome Emergency Services District #1 (Jonestown) and Emergency Services District #5 (Manchaca) to the Automatic Aid Group.

Effective January 3 and January 4, 2017, respectively, these two ESDs will go "live" as full Automatic Aid partners. Both districts have worked extremely hard to prepare themselves for this transition; while we understand there may always be growing pains in any new partnership, I have complete confidence in these two agencies to maintain the standard that the Auto Aid Group expects from our partners. With these additions, we are one step closer to providing true "closest unit response" throughout the county.

We have also begun conversations with Emergency Services District #4 (Fire Control) and Emergency Services District #12 (Manor) about their inclusion in the group during the 2017 calendar year. Both districts have expressed an interest and we will begin cross-departmental training and evaluation in the spring.

Lastly, it has been several years now since we have evaluated our response plans. Early next year, we will begin working with all of our partners to review the current unit allocations and the response plans for ESDs to determine if we are sending the correct resources. In many cases, this might lead to a reduction of AFD units being assigned to incidents in other districts. As always, our goal is to provide the right resources to the incident, in the right amount of time, without creating a burden on any one department.

AUTOMATIC AID AGREEMENT BETWEEN EMERGENCY SERVICES DISTRICTS OF TRAVIS AND WILLIAMSON COUNTIES AND THE CITIES OF AUSTIN, LEANDER, CEDAR PARK, ROUND ROCK AND GEORGETOWN

STATE OF TEXAS)(
COUNTY OF TRAVIS

This Agreement ("Agreement") is entered into between the Cities of Austin, Leander, Cedar Park, Round Rock and Georgetown ("Cities"), each a home – rule municipal corporation, and the Emergency Service Districts ("ESDs") located in Travis and Williamson Counties, Texas whose signatures are affixed below as of the Effective Date, (all signatories to this Agreement are hereinafter sometimes referred to as the "parties" or singularly as a "party," whether or not capitalized) to provide services and to perform functions that are mutually beneficial to the contracting parties and the residents of their respective jurisdictions.

RECITALS

The ESDs and the fire departments of the Cities currently provide fire protection and other types of emergency response services in their respective jurisdictions or service areas.

Some of the ESDs and the Cities have previously cooperated with each other in the provision of emergency and fire protection services through mutual aid or first responder contracts, and all of the ESDs and the Cities agree that the additional parties which are entering into this Agreement provide for a more comprehensive arrangement for the provision of emergency services in the metropolitan area covered by all the participating jurisdictions.

The ESDs and the Cities desire to augment resources and capabilities within the geographic boundaries of their respective service areas by responding and dispatching emergency calls on an automatic assistance basis so that the nearest available unit responds to the incidents specified in this Agreement, regardless of the jurisdiction involved.


Authority for entering into this Agreement is found in the Interlocal Cooperation Act, Texas Government Code Chapter 791. Each party's monetary obligations, if any, are for the performance of governmental functions or services and are payable only from the current revenues appropriated and available for the performance of those functions or services.

Purpose


The purpose of this Agreement is to provide for assistance to the Cities and the ESDs, to efficiently enhance the capabilities and coordination of each party's ability to protect lives and property. The original partner agencies in an Automatic Aid Agreement commenced in 2013 (the "2013 Automatic Aid Agreement") were the City of Austin and Travis County ESDs No. 2, No. 3, No. 6, No. 9, No. 10, and No. 11. However, all other emergency services districts in Travis









PURPOSE

To provide the safest possible fireground work environment for all Williamson County and Travis County Fire Department personnel operating at structure fire incidents with automatic aid response, recognize the inherent risks at every scene, simplify decision-making requirements under potentially stressful situations and to meet the requirements of the Texas Commission on Fire Protection (TCFP).

Exhibit A

Automatic Aid Agreement Travis and Williamson County Agencies Operational Guidelines

I. PURPOSE

To establish operational guidelines that will address the basic provision of emergency service response into the designated service areas identified within the Travis and Williamson County Automatic Aid Agreement(s).

II. BACKGROUND

Each agency participating in an Automatic Aid Agreement agrees that automatic aid provides for the most efficient and effective delivery of emergency response services to the citizens of our respective jurisdictions.

However, all agencies must operate under an Incident Command System (ICS) that is National Incident Management System (NIMS) compliant as promulgated by the U.S. Department of Homeland Security. In order for there to be a core standard when it comes to an ICS, all agencies participating in this agreement agree to utilize the "Blue Card" certification system or the Texas Commission on Fire Protection (TCFP) certification for Incident Command qualifications.

These guidelines shall be reviewed at least annually by the participating agencies. Any revisions shall require prior notification, review, and approval from all participating agencies.

III. DEFINITIONS

- "Automatic Aid" is an agreement between jurisdictions to respond the nearest available unit(s) to mitigate an emergency situation.
- "Certified Personnel" are certified as Structure Fire Protection Basic (or higher) through the Texas Commission on Fire Protection (TCFP).
- "Staffing of Units" involves TCFP commissioned Firefighters. Cadets do not count towards staffing, nor should they be riding in apparatus in any other role other than as an observer (non-participant).

PERSONNEL MINIMUMS QUALIFICATIONS

D. Certifications of Personnel

(AHJ shall have a clearance process for members operating in a higher class role. The credentialing of positions below is for those promoted to the specified rank.)

- 1. Firefighter Rank:
- Texas Commission on Fire Protection (TCFP) Structure Fire Protection Basic or higher-level certification
- b. EMT-Basic or higher-level certification
- NIMS 100, 200, 700, and 800 certifications
- d. Preferred qualifications:
 - i. National Wildfire Coordinating Group (NWCG) Wildland Firefighter Type II
- 2. Driver/Apparatus Operator
- a. All lower-rank certifications and;
- b. Minimum of one (1) year experience as a full-time paid firefighter
- c. State of Texas Class A, B, or B Exempt criver's license
- d. TCFP Driver/Operator certification
- e. Preferred qualifications:
 - i. Blue Card or TCFP Incident Commander certification
 - ii. NWCG Wildland Firefighter Type I
 - iii. NWCG Engine Operator
- 3. Lieutenant
 - a. All lower-rank certifications and;
 - b. Minimum of two (2) years' experience as a Driver/ Apparatus Operator
 - c. TCFP Fire Officer I certification
 - d. NIMS 300,400, and 703 certifications
 - e. Preferred qualifications:
 - i. Blue Card or TCFP Incident Commander certification
 - ii. NWCG Engine/Crew Boss certification

 - h. A202 Mid-Rise Fires
 - i. A708 Response to Alarm Activations
 - j. A610 Response to Active Shooter Incidents

AUTOMATIC AID STANDARD OPERATING GUIDELINE APPROVAL PROCESS

PURPOSE

This document is designed to provide guidance and clarity on the process to adopt the Central Texas Regional Procedures for the Fire Chiefs in the Travis County/ Williamson County Automatic Aid Coalition.

BACKGROUND

In February 2020 during the development of the Automatic Aid Interlocal Agreement the Fire Chiefs agreed that the automatic aid partners should work to implement standardized, regional operating guidelines for all automatic aid agencies. Although there may be several regional procedures, it was decided to work toward the adoption of Incident Command, Fireground Operations and Mayday/ Rapid Intervention Crew. Sub-Committees were established and the first products were submitted to the coalition fire chiefs in September 2020. In the spirit of cooperation, all coalition fire chiefs have committed to the development of the regional guidelines and agree that standardized guidelines provide the safest possible work environment for personnel operating at emergency incidents, improve the use of agency resources, and meet federal, state and local regulations.

PROCESS FOR ADOPTION

- A. Establish Sub-Committee Members
 - The Capital Area Fire Chief Association Automatic Aid Committee Chair shall establish
 working automatic aid committees to discuss, design and develop requested Central
 Texas Regional Procedures. Multiple committees may be working on separate
 individual procedures or may be working in collaboration to develop procedures.
- The Automatic Aid Committee Chair shall provide notice to all automatic aid fire chiefs on the topic the working committee will be creating. The Fire Chief or their designee may assign a department member to be on the committee, but a department may not request more than 2 members on any one committee.
- A Committee Chair should be established on any working automatic aid committee.The Chair will provide goals, set meeting dates and work with other Chairs as needed to complete the procedure.
